#### 558. Chair's Welcome

Cllr. Melaney welcomed everyone to the meeting and explained that, following apologies, there would be a full presentation about the proposed Byers Gill Solar by representatives of the project from JBM.

# 559. Public Participation

4 members of the public were present.

# 560. Presentation about proposed Byers Gill Solar Farm by Michael Baker from JBM Solar

A detailed presentation was made by the representatives of the proposed Byers Gill Solar Farm. The presentation included some feedback from previous questionnaire consultation including:

- Proposals to relocate entrance to site and also now using access from A1, not A66, as a priority;
- Details of a reduction in size whilst still maintaining 180mw target;
- Confirmation that the planning application would be submitted in January 2024 and that full consultation and comment would then be welcomed;
- Any gueries or comments to be sent to dedicated Byers Gill Solar Enquiries Line;
- The presentation was promised to be circulated by Michael Brown.

Following the presentation those present expressed unanimous opposition to the proposals based around the following headings:

- Scale of proposals so close to village settlements of Bishopton and Great Stainton in particular;
- Lack of extensive or appropriate consultation. This included criticism of not holding detailed dialogue with residents in most affected areas whilst undertaking consultation in Stockton Town Centre with people not affected;
- Aesthetics of the project and destruction of local environment;
- Disruption to village caused by necessary works linked to proposals especially if consent not granted by landowner for location of power cable to Norton substation;
